Where do we collect information about you?

We collect information about your business and your client in the following ways:

When you give it to us DIRECTLY

We obtain information about your client when they:

- Attend our practice as a patient
- You instruct us to complete a report on behalf of your client, with or without an examination
- Complete documentation such as a Medical History form
- Agree to or request referral to other professionals
- Receive support from us by contacting us by telephone, text or email



When you give permission to OTHER ORGANISATIONS to share

• If you permit other organisations to give us information such as when you instruct a solicitor or agency to act on your behalf.

What type of information

The type and quantity of information we collect and how we use it depends on why you are providing it.

Typically, the basic personal information we collect about your client might include:

- Their name
- Their contact details
- Their email address
- Their telephone number
- Their GP name and practice address
- Their next of kin or carer contact details
- Their previous medical records

If they use our website we collect any information you provide when filling out our contact form.

How do we use your information?

- We process and use the client's information to provide you with a medico legal report and a dental examination, where necessary.
- We collect your IP address to monitor website performance.

How long do we keep this information?

- We keep yours and your client's information until the case is complete...
 - Examination record including radiographs and photographs 11 years or until age
 25
 - o Previous medical records Destroyed after case completion or returned to solicitors
 - Medico Legal Report and associated correspondence Kept for 10 years after case completion.

How do we keep this information safe?

• When you give us personal information, we take steps to ensure that there are appropriate technical measures in place to protect it. Access is restricted only to those who are entitled to see the data, our online communication with solicitors, other dental professionals and medico legal agencies, is always encrypted and our network is protected and routinely monitored.
